Action Items:

Date: Sept. 5, 2013

- 1. Recommend the Mileage equalization Grant be changed to 2013-2014 Equalization mini-grant program and reviewed in a year.
- 2. Based on feedback from surveys, recommendation to have steering committee revisit DA structure to develop a way to include everyone and invite teaching/sharing opportunities.
- 3. Committee recommends a discussion at the DA meeting on the topic of Outreach. Directors will break into 4 groups (each facilitated by a System Services Ad Hoc Committee member) to discuss the statement "MHLS provides information & awareness that assists my library in making community partnerships." There will be a reporting-out from each group to the whole, followed by a group discussion.

Discussion Items:

- Review Mileage Equalization Grant- More restrictive than originally discussed. Reimbursement only to libraries already reimbursing directors. Suggestion to have a letter sent to member BOTs reiterating the importance of Director attendance at meetings and encouraging travel reimbursement.
 Process need to be as simple as possible without a lot of paperwork.
 This Committee was disappointed to hear after all the time and thought put into it, the MHLS BOT committee may be tabling the Equalization Grant until a new System Director is hired.
 Members still feel MHLS BOT members should not get reimbursed for travel.
- 2. 2014 Tentative member's assessment Consensus of Committee to approve and recommend 2014 Member Assessment. Remove goal for MHLS BOT to adopt assessment fee in July for following year.
- 3. Review 2012 Director and Board President Surveys- MHLS received good information and is implementing services in response. Would like to get more participation from Board Presidents. Committee recommends a longer time period for Board Presidents to complete survey to give them the option of including full Board
- 4. Reviewed results of last DA breakout session- Next possible breakout session- Outreach.

DA New Business: November Break-Out Discussion Session on MHLS Plan of Service Element: Outreach

- **Background:** As part of the ongoing evaluation of MHLS System Services as related to the 2012-2016 Plan of Service, the System Services Advisory Committee has recommended a multi-element evaluative mechanism that includes surveys as well as face-to-face discussions.
- **Issue:** An element of the process includes break-out discussion sessions at Director's Association meetings on various Plan of Service elements.
- Recommendation: The System Services Ad Hoc Committee recommends a discussion at the DA meeting on the topic of Outreach. Directors will break into 4 groups (each facilitated by a System Services Ad Hoc Committee member) to discuss the statement "MHLS provides information & awareness that assists my library in making community partnerships." There will be a reporting-out from each group to the whole, followed by a group discussion.
