- 4. Sierra Access Licenses: All member libraries receive two licenses free of annual maintenance charges. However, the access licenses are the basis for the Sierra Capital Fee. Members pay an annual maintenance fee of \$300 per license for each additional license. Effective 2020, any new license will be billed separately and increase 2% each year.
